

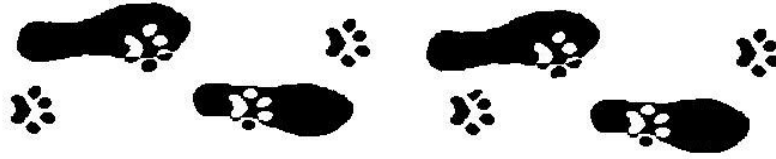

**DIRECTIONS TO TEST SITE:**

**From the South (Chicago)** go North on I-90/I-94

Take I-94 (Edens Expressway) [Portions Toll] North to Half Day Road Turn West on Half Day Road for 2.35 miles. Turn South on Milwaukee Avenue for .39 miles to Knight's Bridge Road. Turn Right into Lincolnshire Corporate Park

**From the North (Milwaukee)** go South on I-94 [Portions Toll]

to Half Day Road. Turn West on Half Day Road for 2.35 miles. Turn South on Milwaukee Avenue for .39 miles to Knight's Bridge Road. Turn Right into Lincolnshire Corporate Park

**SPECIAL NOTICE: Dogs Running Free**

Pursuant to Section 16 of the AKC Regulations - DOGS RUNNING FREE: Due to the changing nature of the fields being used by clubs for tracking tests and the increased population at these sites by the general public, dogs shall be "on lead" at all times on any area of the tracking site. A dog that is allowed to run free and off-lead, at any time before the test, during the test, after failing or after completion of it's track, shall be failed and excused. If this occurs before the test, the dog shall be excused and not allowed to run in the test.

**SPECIAL NOTICE:**

In accordance with AKC Regulations, entries in this tracking test will be accepted up until the official closing date, even though the advertised limit has been reached.

**A drawing will be held in the office of SandStorm Kennels, N3307 Rock Rd, Cascade, WI 53011 on Thursday, September 3, 2009, at 6:00pm, to determine which entries will participate in the test.**

This drawing, conducted by the test secretary, shall be completely at random from among the entries received, except that preference shall be given to those entries that have not earned a VST title.

When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above.

The test secretary will notify all entries of the result of the drawing. Alternates have the option to accept or decline being placed on the alternate list. Those who opt to decline shall have their entry fees returned upon written notification of the test secretary of their intention to withdraw from the alternate list.

In the event an accepted entry cancels after the closing of entries, the test secretary shall contact alternates in the order of their placement on the alternate list. Upon such notification, alternates shall have the option to accept or decline the opportunity to participate in the test.

No entry fee will be refunded except that of an alternate who does not participate in the test. Exception: In the event that an accepted entry withdraws from the test and an alternate replaces that entry, refund will be made to the withdrawn entry.

In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the test secretary to determine if alternates are present, and to determine, by their position on the alternate list, which of the alternates will participate.

The assignment of dogs to the tracks is the responsibility of the judges.
